#### THE IMMIGRANTS AND EMIGRANTS ACT, No. 20 OF 1948

REGULATIONS made by the Minister of Defence and External Affairs by virtue of the powers vested in him by section 48 of the Immigrants and Emigrants Act, No. 20 of 1948, and approved by the Senate and the House of Representatives under that section.

#### Regulations

1. These regulations may be cited as the Immigrants and Emigrants Regulations, 1956.

#### VISAS

2. Every person to whom section 10 of the Act applies and who desires to enter Ceylon is hereby, in terms of paragraph (b) of that section, required to have in his possession a visa.

3. (1) Exemption from the provisions of section 10 of the Act may be granted to-

- (a) any person to whom an identity certificate is issued under regulation 37, if such identity certificate bears an endorsement authorising his entry into Ceylon, or
- (b) any person under sixteen years of age if the particulars relating to the name, date of birth and sex of such person are entered in a valid passport of the parent accompanying such person and if such parent is in possession of a visa except where such parent has been exempted from the requirement of having a visa.

(2) Exemption from the requirement of having a visa for entering Ceylon may be granted to—

- (a) any person who is a bona fide tourist, if such person is in possession of a valid passport and, where so required by the law of the country to which he is ultimately bound, a visa authorising his entry into that country, or
- (b) any person who, being a passenger on board a ship, desires to enter Ceylon and remain in Ceylon for the duration of the stay of that ship in an approved port, if such person is in possession of a valid passport and, where so required by the law of the country to which he is ultimately bound, a visa authorising his entry into that country;
- (c) any person who has ceased to be a citizen of Ceylon by descent by reason of his having failed to renounce the citizenship of any other country, if such person is in possession of a valid passport or a document of identity issued by the Government of the country of which he is a citizen, or
- (d) any person who is a member of the Naval, Military or Air Forces of the Republic of India, if such person is in possession of a valid passport or a document of identity and a valid movement order issued by the Government of India, or
- (e) any person who is a member of the civilian staff of Her Majesty's Naval, Military or Air Force Establishment in Ceylon, if such person is in possession of a valid passport, or
- (f) any person who is the wife or a dependent child of any person referred to in sub-paragraph (e), if such wife or dependent child is in possession of a valid passport, except where such wife or child has been exempted from the requirement of having a valid passport.
- Visas issued under these regulations shall be of the following classes—

   (a) Residence Visas.
  - (b) Visit Visas.
  - (c) Transit Visas.

5. Any one of the following persons shall be a prescribed authority for the purpose of granting, issuing or extending visas :--

- (a) The Controller of Immigration and Emigration.
- (b) A Deputy Controller of Immigration and Emigration.
- (c) An Assistant Controller of Immigration and Emigration.
- (d) The Statistical Assistant, Department of Immigration and Emigration.
- (e) The Chief Clerk, Department of Immigration and Emigration.
- (f) A person accredited by the Government of Ceylon to the Government of any other country.
- (g) A member of the Ceylon Overseas Service of a rank not below that of Third Secretary.
- (h) The Chief Clerk of any Ceylon Diplomatic Mission abroad.
- (i) A Passport or Visa Officer of the Government of the United Kingdom, Australia, Canada, Pakistan, New Zealand or South Africa.
- (j) The Passport Officer of the Government of the Maldive Islands.
- (k) The Government Agent of the administrative district of Jaffna.
- An Assistant Government Agent functioning in the administrative district of Jaffna.
- (m) An Office Assistant to the Government Agent of the administrative district of Jaffna.
- (n) The Commissioner for the Registration of Indian and Pakistani Residents.

- (o) A Deputy Commissioner for the Registration of Indian and Pakistani Residents.
- (p) The Ceylon Emigration Commissioner, Thiruchirapalli.
- (q) The Chief Clerk of the Office of the Ceylon Emigration Commissioner, Thiruchirapalli
- (r) The Ceylon Trade Commissioner, Bombay.

6. Every application for a visa shall be made to the prescribed authority in such one of the Forms A to C set out in the First Schedule hereto, as may be appropriate to the case, and shall contain all the particulars required to be entered therein.

7. A parent or duly appointed guardian may make an application for a visa on behalf of a child or dependent under sixteen years of age.

8. (1) Where an application is made for a visa in respect of any person, the prescribed authority may require the person applying for the same to furnish such number of copies of the photograph or of the finger-prints or of both, as he may specify, of the person in respect of whom the application is made.

(2) Every copy of a photograph or of the finger-prints furnished under paragraph (1) of this regulation, shall be authenticated in such manner as the prescribed authority may require.

9. The prescribed authority may require any person to whom a visa has been issued or who has made an application for the grant, issue or extension of a visa to furnish such information, or to produce such documents, as the prescribed authority may consider relevant to the grant, issue or extension of that visa.

10. (1) The prescribed authority may grant or issue a visa to any person—

- (a) if such authority is satisfied that such person is of good character;
- (b) if such authority approves the purpose for which such person is entering Ceylon;
- (c) if such person is the holder of a valid passport which provides for his entry into Ceylon ; and
- (d) if such authority is satisfied that such person has adequate funds for his maintenance in Ceylon and for the payment of his return passage to the country which issued his passport.

(2) The prescribed authority may, in addition to the conditions specified in paragraph (1) for the grant or issue of a visa, as a condition precedent to its grant or issue, require the applicant for a visa or a person on his behalf approved by such prescribed authority, to furnish security—

- (a) by the deposit with the prescribed authority or a Government Agent of such sum of money as the prescribed authority may determine, or
- (b) by the execution of a bond for the payment of such sum of money as the prescribed authority may determine; or
- (c) by the hypothecation of immovable property of such value as the prescribed authority may determine.

(3) Where there is a contravention or non-fulfilment of any term or condition in any visa granted or issued to any person in relation to whom security has been furnished under the provisions of paragraph (2), the whole or part of any such security shall be forfeited to the Crown.

11. It shall be lawful for the prescribed authority to forfeit the whole or part of any security furnished by any person for the grant of any visa or temporary residence permit issued before the date on which the Immigrants and Emigrants (Amendment) Act, No. 16 of 1955, came into  $1^{*-R}$  13045 (3/66)

operation and in force after that date, if there has been any contravention or non-fulfilment of any term or condition—

(a) in such visa or permit, or

(b) in the bond executed for the purpose of furnishing such security.

12. No visa to enter Ceylon shall be granted or issued to any person referred to in section 11 (2) of the Act, except—

- (a) where such person is dangerously ill and is in need of immediate medical attention; or
- (b) where the Minister directs that a visa be granted or issued to such person.

13. (1) The fees payable in respect of visas shall be as follows :--

(a) For the grant or issue of a residence visa .. 2 00 for each period of twelve

(b) For the grant or issue of a visit visa ... 2 00 (c) For the grant or issue of a transit visa ... 1 00

Provided, however, that no fee shall be payable for the grant or issue of a visa to any person who-

- (a) is the holder of a diplomatic or official passport; or
- (b) is the holder of a valid diplomatic or official endorsement on his passport.

(2) Notwithstanding anything to the contrary in paragraph (1) —

- (a) a national of a country (other than Ceylon) may be required to pay for a visit visa or transit visa, a sum not exceeding the amount that a citizen of Ceylon would be liable to pay for a visa for that country; and
- (b) where a visit visa or a transit visa is granted or issued to any person by the representative of another Government on behalf of the Government of Ceylon, such person may be required to pay for that visa any sum fixed between the two Governments.

14. A residence visa may be granted or issued to any person for a single journey or for several journeys.

15. A visit visa may be granted or issued to any person for such period not exceeding six months as may be specified in such visa.

16. A transit visa may be granted or issued for such period not exceeding one month as may be specified in such visa to a person travelling through Ceylon.

17. Every visa granted or issued to any person under these regulations shall be so granted or issued that such visa shall expire on a date which is at least two months before the date of expiry of the passport held by such person.

18. Where the law of any country to which a person is ultimately bound requires that person to have in his possession a visa authorising his entry into that country, no transit visa shall be granted or issued to such person unless he has in his possession a visa as required by the law of that country.

19. (1) Every residence visa shall substantially in Form D or Form D<sup>+</sup> set out in the First Schedule hereto, as may be appropriate to the case.

(2) Every visit visa shall be substantially in Form E or Form E' set out in the First Schedule hereto, as may be appropriate to the case.....

(3) Every transit visa shall be substantially in Form F or Form F<sup>1</sup> set out in the First Schedule hereto, as may be appropriate to the case.

20. (1) It shall be a condition of every visa that the prescribed authority may, in his absolute discretion, cancel, vary or amend such visa or any term or condition specified therein.

(2) Where the prescribed authority cancels, varies or amends any visa, he shall cause notice of the cancellation, variation or amendment, as the case may be, to be served on the holder of that visa.

21. It shall be a condition of every visa that the holder thereof shall produce, or cause to be produced, his passport and visa for inspection whenever required to do so by the prescribed authority or an authorized officer.

22. It shall be a condition of every residence visa that the prescribed authority may provide—

- (a) that the holder thereof shall not engage in any employment, whether paid or unpaid, or in any trade or business, during his stay in Ceylon; or
- (b) that the holder thereof shall not engage in any employment, trade or business other than that specified in the visa, without the express written permission of the prescribed authority.

23. It shall be a condition of every visit visa and transit visa that the holder thereof shall not engage in any employment, whether paid or unpaid, or in any trade or business, during the period of his stay in Ceylon.

24. Every residence visa shall cease to be valid—

- (a) on the expiration of the period for which such visa was granted or issued; or
- (b) on the cessation of the purposes for which such visa was granted or issued;
- (c) on the cessation of any term or condition subject to which such visa was granted or issued; or
- (d) on the non-fulfilment or violation of any term or condition subject to which such visa was issued.

25. A residence visa granted or issued to a child shall cease to be valid after that child attains the age of sixteen years :

Provided, however, that where the prescribed authority, upon application made in that behalf, extends the period of such visa, the visa shall continue to be valid for the period for which it is extended.

26. Where a residence visa issued to any person has ceased to be valid any visa granted or issued to the spouse, or a dependant, of that person solely on the ground that that person is the holder of a residence visa shall cease to be valid.

#### ENDORSEMENTS UNDER PART III OF THE ACT

27. Every endorsement under Part III of the Act shall be substantially in such one of the Forms G to G2 set out in the First Schedule hereto, as may be appropriate to the case.

28. Where an authorized officer requires under section 13 (3) of the Act that security be furnished as a condition precedent to the grant of an endorsement to a passport holder, such security shall be furnished by the deposit of such amount, not exceeding five hundred rupees, as the officer may determine, or by the execution of a bond for the payment of such amount, or by the hypothecation of immovable property for such amount.

29. An authorized officer may grant an endorsement to the holder of a passport on the condition that such holder will report to the Controller within the period specified in that endorsement.

30. No endorsement shall be granted to any person referred to in section 11 (2) of the Act, except—

- (a) where such person is dangerously ill and is in need of immediate medical attention; or
- (b) Where the Minister directs that an endorsement be granted to such person.

31. The Controller of Immigration may in the case of any endorsement granted under the Act—

- (a) extend or restrict the period for which such endorsement is granted; or
- (b) cancel, vary or amend any term or condition subject to which such endorsement is granted.

32. It shall be a condition of every endorsement that the person to whom it is granted shall not engage in any employment, whether paid or unpaid, or in any business or trade, during the period of his stay in Ceylon unless he is authorized so to do by the visa granted or issued to him by the prescribed authority.

33. No endorsement shall be granted to a person for any period exceeding six months from the date of its issue except in a case where the visa granted or issued to him authorizes his stay in Ceylon for any longer period.

34. Every endorsement granted to any person under these regulations shall be so granted that such endorsement shall expire on a date which is at least two months before the expiry of the passport held by such person:

Provided, however, that an endorsement may, in such circumstances as the authorized officer who issues the endorsement may deem exceptional be so granted that such endorsement will expire on a date which is not later than the date of expiry of the passport held by the person to whom such endorsement is granted.

35. Every extension of an endorsement shall be substantially in Form H set out in the First Schedule hereto.

#### PASSPORTS, EMERGENCY CERTIFICATES AND IDENTITY CERTIFICATES

36. Any one of the following persons shall be a competent authority for the purposes of issuing or renewing passports :--

- (a) The Controller of Immigration and Emigration.
- (b) A Deputy Controller of Immigration and Emigration.
- (c) An Assistant Controller of Immigration and Emigration.
- (d) The Statistical Assistant, Department of Immigration and Emigration.
- (e) The Chief Clerk, Department of Immigration and Emigration.
- (f) A person accredited by the Government of Ceylon to the Government of any other country.
- (g) A member of the Ceylon Overseas Service of a rank not below that of Third Secretary.
- (h) The Chief Clerk of any Ceylon Diplomatic Mission abroad.
- (i) The Ceylon Trade Commissioner, Bombay.
- (j) A passport or Visa Officer of the Government of the United Kingdom.

37. (1) The certificate to be issued for the purposes of the proviso to section 35 of the Act to any citizen of Ceylon to whom Part VII of the Act applies, and who desires to travel to India, Pakistan, the Federation of Malaya, Singapore, Burma or Borneo shall be in the Form I (such certificate being hereinafter referred to as "emergency certificate").

An emergency certificate shall be issued by any one of the following officers:-

- (a) The Controller of Immigration and Emigration.
- (b) A Deputy Controller of Immigration and Emigration.
- (c) An Assistant Controller of Immigration and Emigration.
- (d) The Statistical Assistant, Department of Immigration and Emigration.
- (e) The Chief Clerk, Department of Immigration and Emigration.
- (f) The Government Agent of the administrative district of Jaffna.
- (g) An Assistant Government Agent functioning in the administrative district of Jaffna.
- (h) An Office Assistant to the Government Agent of the administrative district of Jaffna.
- (i) A person accredited by the Government of Ceylon to the Government of any other country.
- (j) A member of the Ceylon Overseas Service of a rank not below that of Third Secretary.
- (k) The Chief Clerk of any Ceylon Diplomatic Mission abroad.
- (1) The Ceylon Trade Commissioner, Bombay.

(2) The certificate to be issued for the purposes of the proviso to section 35 of the Act to any person to whom Part VII of the Act applies and who is unable for any reason deemed sufficient by the officer authorized to issue such certificate, to obtain a national passport within a reasonable period of time, shall be in the Form J (such certificate being hereinafter referred to as "identity certificate").

An identity certificate shall be issued by any one of the following officers: ---

- (a) The Controller of Immigration and Emigration.
- (b) A Deputy Controller of Immigration and Emigration.
- (c) An Assistant Controller of Immigration and Emigration.
- (d) The Statistical Assistant, Department of Immigration and Emigration.
- (e) The Commissioner for the Registration of Indian and Pakistani Residents.
- (f) A Deputy Commissioner for the Registration of Indian and Pakistani Residents.
- (g) The Chief Clerk, Department of Immigration and Emigration.

38. Every application for a passport, for an emergency certificate and for an identity certificate shall be substantially in the Forms K, L, M, respectively, set out in the First Schedule hereto, and shall be made to the competent authority or to the appropriate prescribed officer, as the case may be.

39. A parent or duly appointed guardian may make an application for a passport, an emergency certificate or an identity certificate on behalf of a child or dependant under sixteen years of age.

40. The competent authority or the appropriate prescribed officer, as a condition precedent to the issue or renewal of a passport, emergency certificate or identity certificate, may require an applicant or a person on his behalf approved by such authority or officer to furnish security for the repayment to the Government of all expenses that may be incurred in respect of such applicant, by the deposit with such authority or officer or with a Government Agent, of money of such amount, or by the execution of a bond for the payment of money of such amount, or by the hypothecation of immovable property of such value, as such authority or officer may determine.

41. Every passport shall be substantially in the Form N set in the First Schedule hereto.

42. The Minister may, by Order made under section 2 (2) of the Act, exempt from the requirement of having a passport for leaving Ceylon any person under sixteen years of age if the particulars relating to the name, date of birth and sex of such person are entered in a valid passport of the parent accompanying such person.

43. Where the Minister has issued a special direction to the effect that no passport, emergency certificate or identity certificate shall be issued in respect of any person, the competent authority or the appropriate prescribed officer, as the case may be, shall refuse to issue a passport, or an emergency certificate or an identity certificate in respect of that person.

44. The competent authority or the appropriate prescribed officer may—

- (a) endorse any passport, emergency certificate or identity certificate, as the case may be, so as to make it valid for travel to any country or countries not already mentioned therein; or
- (b) cancel any endorsement in any passport, emergency certificate or identity certificate, as the case may be, so as to make it invalid for travel to any country or countries already mentioned therein.

45. (1) A passport, an emergency certificate or an identity certificate shall be valid for travel only to the countries for which it is endorsed.

(2) No holder of a Ceylon passport, an emergency certificate or an identity certificate shall travel to any country other than a country for which such passport, emergency certificate or identity certificate has been endorsed.

46. Every passport shall be valid for such period not exceeding five years from the date of its issue, as may be specified in the passport by the competent authority.

Provided, however, that such authority may renew such passport for a further period not exceeding five years from the date of expiry of the passport.

47. Every emergency certificate or identity certificate shall be valid for such period not exceeding two years from the date of its issue, as may be specified in such certificate by the appropriate prescribed officer:

Provided, however, that the appropriate prescribed officer may renew such certificate for a further period not exceeding two years from the date of expiry of such certificate.

48. Every application for the renewal or alteration of a passport, emergency certificate or identity certificate shall be substantially in the Form O set out in the First Schedule hereto and shall be made to the competent authority or the appropriate prescribed officer, as the case may be. 49. Where an application is made under regulation 48, the applicant shall furnish the competent authority or the appropriate prescribed officer, as the case may be, with such particulars or documents as he may require in connection therewith.

50. A passport, or an emergency certificate or an identity certificate may be issued for a single journey or a specified number of journeys. Where the number of journeys is not specified in any passport, emergency certificate or identity certificate, such passport or certificate shall be valid for any number of journeys during its period of validity.

51. (1) It shall be a condition of every passport, emergency certificate or identity certificate that the competent authority or the appropriate prescribed officer, as the case may be, may in his absolute discretion—

- (a) cancel or suspend the passport, emergency certificate or identity certificate; or
- (b) restrict its period of validity.

(2) Where the competent authority or the appropriate prescribed officer cancels or suspends any passport, emergency certificate or identity certificate, as the case may be, such authority or officer shall cause notice of the cancellation or suspension to be served on the holder of that passport. emergency certificate or identity certificate.

(3) Upon service of a notice under paragraph (2), the holder of the passport, emergency certificate or identity certificate in respect of which the notice was served, shall surrender the passport, emergency certificate or identity certificate to the competent authority or the appropriate prescribed officer, as the case may be, by whom the notice was caused to be served.

52. A new passport, emergency certificate or identity certificate may, upon application made in that behalf, be issued by the competent authority or the appropriate prescribed officer, as the case may be, to any person—

- (a) if his previous passport has ceased to be valid upon the termination of ten years from the date of its issue or if his emergency or identity certificate has ceased to be valid upon the termination of four years from the date of its issue;
- (b) if his previous passport, emergency certificate or identity certificate has been lost or damaged so as to render it unusable; or
- (c) if all the pages of his previous passport, emergency certificate or identity certificate have been exhausted.

53. The fees specified in column II of the Second Schedule hereto shall be charged in respect of the matters relating to passports, emergency certificates or identity certificates, respectively, specified in the corresponding entries in column II of that Schedule.

54. For the purposes of regulations 38, 40, 43, 44, 47, 48, 49, 51 and 52, the expression "prescribed officer" means any person prescribed by regulation 37 to be a prescribed officer.

#### DEPARTURE OF PERSONS FROM CEYLON

55. Every person leaving Ceylon shall produce his passport, emergency certificate or identity certificate before an authorized officer for the purpose of having it stamped by such officer.

#### GENERAL

56. The Controller, Deputy Controller and every Assistant Controller of Immigration and Emigration shall, for the purposes of the Act, have the power to administer oaths.

57. It shall be lawful for any of the persons authorized by these regulations to grant or issue visas, to cause finger-prints to be taken from any person who is not a citizen of Ceylon on the entry into, or departure from, Ceylon of such person.

58. (1) The master of a ship which enters Ceylon shall, without delay, furnish the Controller of Immigration and Emigration or an authorized officer with—

- (a) a list of passengers, stowaways and deportees on board that ship;
- (b) a list of the officers, seamen and other persons employed on that ship;
- (c) a list of all passengers, leaving the ship at Ceylon;
- (d) a list of all passengers leaving Ceylon in that ship; and
- (e) the embarkation and disembarkation cards relating to the passengers and stowaways on board, completed by such persons at the request of the master.

(2) The lists and cards referred to in paragraph (1) shall be substantially in the Forms P, Q, R, S, T and U respectively set out in the First Schedule hereto.

59. If the master of a ship discovers that a stowaway has disembarked from the ship at Ceylon without his permission, he shall, without delay, report the fact to the Controller, Deputy Controller or an Assistant Controller of Immigration and Emigration.

60. The list referred to in section 42 (3) of the Act shall be substantially in the Form V set out in the First Schedule hereto.

61. The prescribed officer for the purposes of section 28 of the Act shall be any one of the following :—

- (a) An authorized officer.
- (b) A Police Officer not below the rank of Sub-Inspector.

62. Any notice required by these regulations to be served on any person shall be deemed to have been duly served on that person if such notice is forwarded by post by registered letter to the address furnished by that person.

63. The Immigration and Emigration Regulations, 1949, published in *Gazette* No. 10,039 of October 28, 1949, are hereby rescinded.

64. In these regulations, unless the context otherwise requires-

- "Act" means the Immigrants and Emigrants Act, No. 20 of 1948, as amended by any other subsequent Act;
- "approved port" means any place in Ceylon declared by Order under section 3 of the Act to be an approved port of entry or an approved port of departure for the purposes of the Act;
- "authorized officer" means any person appointed under section 4 of the Act to be or to act as as an authorized officer;
- "competent authority" means any one of the persons specified in regulation 36 to be a competent authority for the purposes of issuing or renewing passports; and

" prescribed authority " means any one of the persons specified in regulation 5 for the purpose of granting, issuing or extending visas.

The Immigrants and Emigrants Regulations, 1956, published in Gazette No. 10896 of February 24, 1956 as amended from time to time, are hereby further amended as follows :-

(1) by the insertion, immediately after regulation 13 of the above regulations of the following new regulation

"13A (1) All persons who are not citizens of Sri Lanka who intend to travel to Sri Lanka shall in addition to the visa fee payable in terms of regulation 13, pay to the airline company at the time of purchasing the air ticket an additional visa fee of ten (10) United states Dollars or its equivalent in any other foreign currency. It shall be the duty of the airline company to credit all monies collected by way of such additional visa fee to the Controller of Immigration and Emigration.

(2) A sum equivalent to two point five (2.5) percentum of the monies credited to the Controller of Immigration and Emigration as visa fees under paragraph (1) shall be utilized to make incentive payments to all officers and staff members of the Department of Immigration and Emigration who are carrying out duties connected with the issue of visas and officers and staff carrying out duties in any other section of the Department which is connected to the issue and monitoring of Visas.

- (3) Where a visa has been issued to a person who is not a citizen of Sri Lanka, and such persons stay in Sri Lanka exceeds the period permitted by the visa, such person shall be required to pay a penalty in respect of the period for which he has overstayed in Sri Lanka, at such rates as are specified below :-
  - (i) where the period of the overstay has exceeded seven days (07) and has continued upto thirty (30) days calculated fom the date of expiry of the period of validity of the orginal visa, the rupee equivalent of twenty five (25) United States Dollars will be charged as a penalty;
  - (ii) Where the period of the overstay has exceeded thirty (30) days and has continued up to ninety (90) days calculated from the date of expiry of the period of validity of the original visa, the rupee equivalent of fifty (50) United State Dollars will be charged as a penalty ;
  - (iii) Where the period of the overstay has exceeded ninety (90) days calculated from the date of expiry of the period of validity of the original visa, the rupee equivalent of one hundred (100) United State Dollars will be charged as a penalty :

#### Provided that,

- (a) in the case of persons falling within the provision of sub-paragraphs (i), (ii) and (iii) above require the person who has overstayed to forthwith pay the fine and thereafter proceed to include the details of such person in an observation document in such manner as specified by the Controller of Immigration and Emigration, to be checked in the event of such person entering Sri Lanka on a future occasion; and
- (b) in the case of persons who fail to pay the penalty as stipulated above, immediately forward the details of such person to be included in a document in such manner as specified by the Controller of Immigration and Emigration. This document will act as a guide, in preventing if it so becomes necessary, persons whose names are specified therein, from entering Sri Lanka on any future occasion.":
- (2) The provisions of paragraph (3) of this regulation shall be effective from March 01, 2007 and the provisions of paragraphs (1) and (2) of this regulation shall be effective from July 01, 2007.
