## MEDIA RELEASE Department of Immigration and Emigration Revision of visa fees

I would like to inform all persons that the visa fees and fines have been revised as per the new Immigration and Emigration Regulations issued on 18th August 2021 by the Extraordinary Gazette No. 2241/37.

## Penalties for overstay

A foreigner staying in Sri Lanka without a valid visa will be charged US \$ 500 penalty in addition to the visa fee.
