01. The Chairman of the Department Procurement Committee for the Department of Immigration and Emigration invites sealed bids from eligible and qualified bidders for the supply of food for detainees at the Welisara and Mirihana Foreigner Detention Centres.
02. Bidding will be conducted through National Competitive Bidding (NCB).
03. Interested bidders may obtain further information from **the Deputy Controller (Procurement), Procurement Division, Department of Immigration and Emigration, 05<sup>th</sup> Floor, “Suhurupaya”, Sri Subhuthipura Road, Battaramulla** during working days between 9.00 a.m. and 3.00 p.m. from 31.07.2026 to 20.08.2026, and may inspect the bidding documents free of charge at the same address.

A complete set of the printed bidding documents can be obtained upon payment of a non-refundable fee of Rupees Fifteen Thousand (Rs. 15,000.00) and upon submission of a written application to the Deputy Controller (Procurement), Procurement Division, 5<sup>th</sup> Floor, Block B, Department of Immigration and Emigration, “Suhurupaya”, Sri Subhuthipura during working days between 9.00 a.m. and 3.00 p.m. from **31.07.2026 to 20.08.2026**. Payment must be made in cash.
05. Completed bids in two copies, labelled as “Original” and “Duplicate”, should be sent by Registered Post or hand-delivered to the Chairman, Department Procurement Committee, 5<sup>th</sup> Floor, Block “B”, Procurement Division, Department of Immigration and Emigration, Suhurupaya, Sri Subhuthipura Road, Battaramulla at or before **02:00 p.m. on 21.08.2026**. Bids will be opened at the aforementioned address immediately after the closing of bids, in the presence of representatives of bidders who wish to attend. Late bids will not be accepted and will be returned unopened.
06. The bid submitted by bidder shall remain valid for a period of 91 days (20.11.2026) from the closing date of bids or for any extended period.
07. All bids shall be accompanied by a Bid Security, in the format specified in 3.3 of the Bidding Document, addressed to the Controller General of Immigration and Emigration (to the specified address). The Bid Security must be valued at **Rs. 777,600.00**, remain valid until **18.12.2026**, and be issued by a commercial bank operating in Sri Lanka that is approved by the Central Bank of Sri Lanka.
08. The pre-bid meeting will be held on **11.08.2026 at 10.00 a.m.** at the Procurement Division of Immigration and Emigration on the 5<sup>th</sup> Floor of “Suhurupaya”.
