The Chairman, Department Procurement Committee (DPC) on behalf of the Department of Immigration and Emigration invites sealed bids from eligible and qualified bidders for Procurement for supply of food for the detainees at Welisara and Mirihana Foreigner Detention Centres of the Department of Immigration and Emigration.
- 2. This Bidding will be conducted through National Competitive Bidding (NCB) Procedure.
- 3. - 4. A complete set of printed Bidding Document may be purchased on submission of a written application to the Deputy Controller (Procurement), Procurement Division, Wing "B", 05th Floor, Department of Immigration and Emigration, "Suhurupaya", Sri Subhuthipura Road, Battaramulla, during working days between 9.00 a.m. and 3.00 p.m. from **08.09.2025** to **26.09.2025** upon the payment of a non-refundable fee of Rupees Five Thousand Five Hundred (LKR 5,500.00). The mode of payment will be cash.
- 5. Completed bids in two copies as "Original" and "Duplicate" shall be hand delivered or sent by registered post to the Chairman, Departmental Procurement Committee, Wing "B", 05th Floor, Department of Immigration and Emigration, "Suhurupaya", Sri Subhuthipura Road, Battaramulla to reach on or before 10.30 am on 29.09.2025. Bids will be opened at the aforesaid address immediately after closing the invitation of bids in the presence of the representatives of the bidders interested to be present at the occasion. Late bids will not be entertained and such bids will be returned unopened.
- 6. The bids presented by the bidder shall be valid for a period of 91 days (08.12.2025) or any extended period with effect from the last date of accepting bids.
- 7. All bids shall be sent to the address of the Controller General of Immigration and Emigration accompanying a bid Security as mentioned in the form in section 3.3 of the Bidding document. The bid security shall be for an amount of Rs. 500,000.00, shall be valid up to 05.01.2026 and it shall be issued by a commercial Bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka.
- 8. Pre bid meeting will be held at 10.00am on 15.09.2025 at the Office of the Controller General of Immigration and Emigration, 5th Floor of "Suhurupaya".
