1.0 Background

Subsequent to the Bidding Document issued by Department of Immigration and Emigration for “Procurement of Issuance System and Relevant Public Key Infrastructure Components for Personalization of e-Passports to the Department of Immigration and Emigration of Sri Lanka” dated 27th April 2025, addendum 01 to the procurement document was published on 18th June 2025 and addendum 02 to the procurement document was published on 03rd July 2025. Based on the clarifications sought by the Bidder's, it is felt necessary to provide additional information to the bidders to further clarify on certain areas of the Bidding Document.
