1. The Chairman, High Level Procurement Committee (HLPC) on behalf of the **Department of Immigration and Emigration** invites sealed bids from eligible bidders for the **Procurement of Issuance System and Relevant Public Key Infrastructure components for personalization of e-Passports to the Department of Immigration and Emigration of Sri Lanka**
2. Bidding will be conducted through the **International Competitive Bidding (ICB – Single Stage Two Envelope Bidding Procedure)** specified in the National Procurement Guidelines 2024 and are opened to all eligible bidders as defined in the Guidelines.

To be eligible for contract award, the successful bidder shall not have been blacklisted. The qualification criteria for the eligible bidders shall include the following. (Additional qualification requirements are given in the Procurement Documents):

**a) General Experience.**

The Bidder should have at least five (05) years of experience in e-Passport personalization and issuance solution implementation prior to the Bid Submission Deadline.

**b) Specific Experience in contract of similar nature:**

- i. The Bidder should have completed the implementation of an e-Passport personalization and issuance solution, issuing a minimum of Three (3) Million e-Passports using the system in the role of a contractor, within at least the last five (05) years prior to the Bid Submission Deadline.
- ii. The Bidder should have delivered or have in operation at least two (02) e-Passport personalization solutions for e-Passports, supported by reference letters. The minimum value of each project must not be less than fifteen (15) million USD, and the projects must have been completed or operational within the last five (05) years prior to the Bid Submission Deadline. At least one (01) of these projects must be a bidder-operated issuance service project, including a PKI solution.

**c) Quality and Security Requirements:**

Bidder shall be certified with ISO 9001:2015 and ISO 27001.

**d) Average Annual Turnover:**

The bidder should have a minimum average annual turnover of Ten (10) million USD, as evidenced by audited financial reports, within the last three (3) years.

**e) Financial Resources:**

The Bidder must demonstrate access to or availability of financial resources, such as liquid assets, lines of credit, or other financial means, to meet the cash flow requirement of not less than **US\$ 1.8 million**, net of the Bidder's other commitments for this project.

3. 4. A complete set of Procurement Documents in English may be purchased from **Department of Immigration and Emigration** office (address above para 3) by interested bidders on the submission of a written request on a business letterhead, and upon payment of a non-refundable fee of **LKR 250,000.00 or the equivalent amount in a freely convertible currency in Sri Lanka**. The method of payment will be by cash.
5. Bids must be delivered to the address (above para 3) **at or before 3.00 p.m. on June 23, 2025**. Late bids will be rejected. Bids will be opened soon after the bid closing in the presence of the bidders' representatives, who choose to attend **at 3.00 p.m. on June 23, 2025**. All bids must be accompanied by a Bid Security in the form of bank guarantee of not less than **Sri Lankan Fifty Five Million (LKR 55 million) or the equivalent amount in a freely convertible currency in Sri Lanka**.
6. A Pre-Bid Meeting will be held at **10.30 a.m. on May 15, 2025** in the **Auditorium of Ministry of Public Security and Parliamentary Affairs, 17<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla, Sri Lanka**. All interested Bidders may participate to the Pre-Bid meeting.

## SECTION I – INSTRUCTIONS TO THE BIDDERS

This section specifies the procedures to be followed by Bidders in the preparation and submission of their Bids. Information is also provided on the submission, opening, and evaluation of Bids and on the award of Contract.

<b>A. General</b>		
<b>1. Scope of Bid</b>	1.1	In connection with the Invitation for Bids indicated in the Bid Data Sheet (BDS), the Employer, as indicated in the BDS, issues these Procurement Documents for the procurement of Information Technology (IT) Products and Services as specified in Volume 2 - Section VI (Schedule of Requirements). The name, identification, and number of lots (Contracts) of the International Competitive Bidding (ICB) are provided in the BDS.
	1.2	Unless otherwise stated, throughout this Procurement Document definitions and interpretations shall be as prescribed in Volume 3-Section VII (General Conditions) (GC).
<b>2. Source of Funds</b>	2.1	Government of Sri Lanka (GoSL) shall provide the financing required to meet eligible payments under the Contract for which these Procurement Documents are issued.
<b>3. Corrupt Practices</b>	3.1	<p>It is the policy of GoSL that the officials of the procuring entity as well as Bidders, Suppliers, Service Providers and Contractors and their sub-Contractors under GoSL financed Contracts observe the highest standard of ethics during the procurement and execution of such Contracts, in pursuance of this policy, the GoSL;</p> <p>(a) defines, for the purposes of this provision, the terms set Fourth Floor below as follows:</p> <p>i. “corrupt practice” means the offering, giving receiving, or soliciting, directly or indirectly, of anything of value to influence the action of</p>



		<p>any party in the procurement process or the execution of a Contract;</p> <p>ii. “fraudulent practice” means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a Contract;</p> <p>iii. “collusive practices” means a scheme or arrangement between two or more Bidders, with or without the knowledge of the employer, designed to influence the action of any party in a procurement process or the execution of a Contract;</p> <p>iv. “coercive practices” means harming or threatening to harm, directly or indirectly, persons, or their property to influence their participation in a procurement process, or affect the execution of a Contract;</p> <p>(b) will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the Contract; and</p> <p>(c) will sanction a party or its successor, including declaring ineligible, either indefinitely or for a stated period of time, to participate in GoSL financed activities if it at any time determines that the firm has, directly or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for, or in executing, GoSL financed Contract.</p>
	3.2	Furthermore, Bidders shall be aware of the provision stated in the Volume 3- General Conditions (GC 47.1, Termination for Contractor’s Default).
<b>4. Eligible Bidders</b>	4.1	A Bidder may be a private entity or a government-owned entity or any combination of such entities with the intent to enter into an agreement supported by a letter of intent or under an existing agreement in the form of a joint venture, consortium or association

		<p>(JV). Unless specified in the BDS, there is no limit on the number of members in a JV</p> <p>In the case of a Joint Venture (JV):</p> <p>(a) all partners shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms, and</p> <p>(b) the JV shall nominate one of the partners who shall have the authority to conduct all business for and on behalf of any and all the partners of the JV during the Bidding process and, in the event the JV is awarded the Contract, during Contract execution. This shall be evidenced by submitting a Power of Attorney signed by legally authorized signatories of all the partners.</p>
	4.2	<p>A Bidder, and all partners constituting the Bidder, shall have a nationality of an eligible country and shall have legal rights to supply IT products and Services under the Contract resulting from these Procurement Documents. A Bidder shall be deemed to have the nationality of a country if the Bidder is a national or is constituted, incorporated, or registered and operates in conformity with the provisions of the laws of that country. This criterion shall also apply to the determination of the nationality of proposed sub-Contractors or Contractors for any part of the Contract including related services.</p>
	4.3	<p>GoSL considers a conflict of interest to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, Contractual obligations, or compliance with applicable laws and regulations. Bidders and Contractors under GoSL financed Contracts, shall observe the highest standard of ethics. GoSL will take appropriate actions, which include not financing of the Contract, if it determines that a conflict of interest has flawed the integrity of any procurement process. Consequently, all Bidders found to have a conflict of interest shall be</p>

		<p>disqualified. A Bidder may be considered to be in a conflict of interest with one or more parties in this Bidding process if, including but not limited to:</p> <ul style="list-style-type: none"> <li>(a) they have controlling partners in common; or</li> <li>(b) they receive or have received any direct or indirect subsidy from any of them; or</li> <li>(c) they have the same legal representative for purposes of this Bid; or</li> <li>(d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Employer regarding this Bidding process; or</li> <li>(e) A Bidder participates in more than one Bid in this Bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which it is involved. However, this does not limit the inclusion of the same sub-Contractor, not otherwise participating as a Bidder, in more than one Bid; or</li> <li>(f) A Bidder or any of its affiliates participated as a consultant in the preparation of the design and/or technical specifications of the products and services and/or other documents that are the subject of the procurement under these Procurement Documents.</li> </ul>
	4.4	<p>A firm that is under a declaration of ineligibility by <b>GoSL, International Financial Institutions (ADB, World Bank, etc.) or any other Country</b> in accordance with ITB 3 at the date of the deadline for Bid submission or thereafter, shall be disqualified.</p>
	4.5	<p>Bidders shall provide such evidence of their continued eligibility satisfactory to the Employer, as the Employer shall reasonably request.</p>
	4.6	<p>In case a prequalification process has been conducted prior to the Bidding process, this Bidding</p>

		is open only to prequalified Bidders.
	4.7	Local Companies bidding for these tender or Local partners of Foreign Companies bidding for this tender shall be registered under the Public Contracts Act, No 3 of 1987.

<b>5. Eligible IT Products and Services</b>	5.1	<p>For the purposes of these Procurement Documents, the IT Products and Services means all:</p> <p>(a) the required information technologies, including all information processing and communications-related hardware, software, supplies and consumable items that the Bidder is required to supply and install under the Contract, plus all associated documentation, and all other materials and products to be supplied, installed, integrated, and made operational (collectively called the products in some clauses of the ITB); and</p> <p>(b) the related software development, transportation, insurance, installation, customization, integration, commissioning, training, technical support, maintenance, repair, and other Services necessary for proper operation of the products to be provided by the selected Bidder and as specified in the Contract.</p>
	5.2	The IT Products and Services to be supplied under the Contract shall have their origin in eligible source countries as defined in ITB 4.2 above and all expenditures under the Contract will be limited to such IT Products and Services.
	5.3	For the purposes of ITB 5.2 above - origin means the place where through software development, manufacturing, or substantial and major assembly or integration of components, a commercially recognized Product results that is substantially different in basic characteristics or in purpose or utility from its

		components.
<b>6. Intellectual Property</b>	6.1	By signing the Bid Submission Form, the Bidder represents that it either is the owner of the Intellectual Property Rights in the Products and Services offered, or that it has proper authorization and/or license to offer them from the owner of such rights. Willful misrepresentation of these facts shall be considered fraudulent practice subject to the provisions of ITB 3.1 through 3.2 above, without prejudice of other remedies that the Employer may take.
<b>7. Status of Sub - Contractors</b>	7.1	If it is allowed in the BDS for Sub-Contractors to be nominated for certain components to be taken into account in assessing the Bidder's overall qualifications, any Sub-Contractor so nominated by any Bidder is automatically disqualified from being a Bidder itself or a partner in a Joint Venture. Non-compliance may result in the rejection of all Bids in which the affected firm participates as Bidder or as partner in a Joint Venture.
	7.2	Any firm not participating as Bidder or as partner in a Joint Venture may be proposed as a Sub-Contractor in any number of Bids.  A firm which is a Bidder, whether as a single Bidder or as a partner in a Joint Venture, cannot be a Sub-Contractor in other Bids, except for the supply of commercially available Hardware or Software by the firm, as well as purely indicated services such as installation/configuration, routing training and ongoing maintenance support.
	7.3	If a Bidder intends to Sub-Contract major items of Products and Services, it shall include in the Bid details of the name and nationality of the proposed Sub-Contractor, including vendors for each of those items and shall be responsible for ensuring that any Sub-Contractor proposed complies with the requirements of ITB 3.
	7.4	Bidders are free to list more than one Sub-Contractor against each item. Quoted rates and prices will be

		deemed to apply, whichever Sub-Contractor is appointed, and no adjustment of the rates or prices will be permitted. The Employer reserves the right to delete any proposed Sub- Contractor from the list. This shall be done prior to Contract signature, by deleting such unacceptable Sub-Contractors in Volume 3-Appendix 3 of Section IX (Contract Forms), which shall list the approved Sub- Contractors for each item prior to Contract signature. Subsequent additions and deletions from the list of approved Sub-Contractors shall be performed in accordance with GC Clause 20.												
	7.5	The Employer, where applicable, may select only some of the listed Sub- Contractors in evaluating a Bid. The criteria for selection will be set out in the BDS.												
8. Contacting the Employer	8.1	From the time of Bid advertisement to the time of Contract award, if any Bidder wishes to contact the Employer on any matter related to the Bid, it should do so in writing.												
	8.2	If a Bidder tries to directly influence the Employer or otherwise interfere in the Bid submission and evaluation process and the Contract award decision, its Bid may be rejected.

	9.2	The Invitation for Bids issued by the Employer is not part of the Procurement Document and is intended for references only. In case of inconsistencies, the actual Procurement Documents shall prevail.
	9.3	The Employer is not responsible for the completeness of the Procurement Document and its addenda, if they were not obtained directly from the source stated by the Employer in the Invitation for Bids.
	9.4	The Bidder is expected to examine all instructions, forms, terms, and specifications in the Procurement Document. Failure to furnish all information or documentation required by the Procurement Document may result in the rejection of the Bid.
<b>10. Clarification of Procurement Document, Site Visit, Pre-Bid Meeting</b>	10.4	A prospective Bidder requiring any clarification of the Procurement Document shall contact the Employer in writing at the Employer's address indicated in the BDS or raise his enquiries during the pre-Bid meeting if provided for in accordance with ITB 10.4. The Employer will respond to any request for clarification, provided that such request is received no later than fourteen (14) days prior to the deadline for submission of Bids. The Employer's response shall be in writing with copies to all Bidders who have acquired the Procurement Document in accordance with ITB 9.3, including a description of the inquiry but without identifying its source. Should the Employer deem it necessary to amend the Procurement Document as a result of a request for clarification, it shall do so following the procedure

		under ITB 11 and ITB 26.2.
	10.2	The Bidder, may on notifying the Employer in writing within the time stated in the BDS, visit and examine the site/s where the IT Products and Services are to be installed and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid and entering into a Contract for the provision of IT Products and Services. The costs of visiting site(s) shall be at the Bidder's own expense.
	10.3	The Bidder and any of its personnel or agents will be granted permission by the Employer to enter upon its premises and lands for the purpose of such visit, but only upon the express condition that the Bidder, its personnel, and agents will release and indemnify the Employer and its personnel and agents from and against all liability in respect thereof, and will be responsible for death or personal injury, loss of or damage to property, and any other loss, damage, costs, and expenses incurred as a result of the inspection. No site visits shall be arranged or scheduled after the deadline for submission of the Bids and prior to the award of the Contract.
	10.4	The Bidder's designated representative is invited to attend a pre-Bid meeting, if provided for in the BDS. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.
	10.5	The Bidder is requested, as far as possible, to submit any questions in writing, to reach the Employer not later than one week before the meeting.
	10.6	Minutes of the pre-Bid meeting, including the text of the questions raised without identifying the source, and the responses given, together with any responses prepared after the meeting, will be transmitted promptly to all Bidders who have acquired the Procurement Document in accordance with ITB 9.3. Any modification to the Procurement Document that



		may become necessary as a result of the pre-Bid meeting shall be made by the Employer exclusively through the issue of an addendum pursuant to ITB 11 and not through the minutes of the pre-Bid meeting. The minutes of the Pre-Bid meeting and all addendums will be published on Employer's official website.
	10.7	Nonattendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
<b>11. Amendment of Procurement Document</b>	11.1	At any time prior to the deadline for submission of Bids, the Employer may amend the Procurement Document by issuing addenda.
	11.2	Any addendum issued shall be part of the Procurement Document and shall be communicated in writing to all who have obtained the Procurement Document from the Employer in accordance with ITB 9.3. The minutes of the Pre-Bid meeting and all addendums will be published on Employer's official website.
	11.3	To give prospective Bidders reasonable time in which to take an addendum into account in preparing their Bids, the Employer may, at its discretion, extend the deadline for the submission of Bids, pursuant to ITB 26.2.
<b>C. Preparation of Bids</b>		
<b>12. Cost of Bidding</b>	12.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Employer shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Bidding process.
<b>13. Language of Bid</b>	13.1	The Bid, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Employer, shall be written in the English language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in the

		English language, in which case, for purposes of interpretation of the Bid, such translation shall govern.
<b>14. Documents Comprising the Bid</b>	14.1	The documents comprising the Bid are listed in Section IV (Bidding Forms), in the Bidder Response Format (BRF). Bidders must use the BRF provided to structure and submit their Bids.
	14.2	The Bid shall comprise two envelopes submitted simultaneously, one called the Technical Bid containing the documents listed in Table 1 (Bidder's Response Format – Technical Bid of Section IV (Bidding Forms), and the other the Price Bid containing the documents listed in e 2 (Bidder's Response Format – Price Bid of Section IV (Bidding Forms), both envelopes enclosed together in an outer single envelope.
	14.3	Any other documents required as listed in the BDS

Whenever a discrepancy arises between the item-by-item commentary and any catalogues, technical

		specifications, or other pre-printed materials submitted with the Bid, the item-by-item commentary shall prevail.
	19.5	A Preliminary Project Plan is required, the details of which are described in Volume 2 - Section VI (Schedule of Requirements).
	19.6	A written confirmation that the Bidder accepts responsibility for the successful integration and interoperability of all IT Products and Services as required by the Procurement Documents.
	19.7	For purposes of the commentary to be furnished pursuant to ITB 19.4, the Bidder shall note that any references to brand names or model numbers or national or proprietary standards designated by the Employer in Volume 2 - Section VI (Schedule of Requirements) are intended to be descriptive and not restrictive (except where explicitly prohibited in the BDS for specific items or standards). Items against which no price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed to be covered by the prices for other items.
	20.2	Bidders shall give a breakdown of the prices in the manner and detail called for in the Price Schedules included in Section IV (Bidding Forms).
	20.3	The price of items that the Bidder has left blank in the cost tables provided in the BRF shall be assumed to be included in the price of other items. Items omitted altogether from the price tables shall be assumed to be omitted from the Bid and, provided that the Bid is substantially responsive, an adjustment to the Bid price will be made during evaluation in accordance with ITB 42.1(c) (i).

	29.8	All other envelopes holding Price Bids shall be opened one at a time, reading out: the name of the Bidder, and indicating whether there is a modification or substitution; the Bid Prices, including any discounts and alternative offers, and any other details as the Employer may consider appropriate. Only Price Bids, discounts, and alternative offers read out and recorded during the opening of Price Bids shall be considered for evaluation. No Bid shall be rejected at Bid opening.
	29.9	The Employer shall prepare a record of the opening of Price Bids that shall include, as a minimum: the name of the Bidder, the Bid Price (per lot if applicable), any discounts, and alternative offers. 	34.4	If a Bid is not substantially responsive to the requirements of the Procurement Document, it shall be rejected by the Employer and may not subsequently be made responsive by correction of the material deviation, reservation, or omission.

	23.5	The Employer shall introduce all new versions, releases or updates of the Software within eighteen (18) months of receipt of a production-ready copy of the new version, release, or update, provided that the new version, release, or update does not adversely affect System operation or performance or require extensive reworking of the System. - d) General Conditions of Contract
- e) The Contractor’s bid and original Price Schedules
- f) Addenda/clarifications issued by the employer
